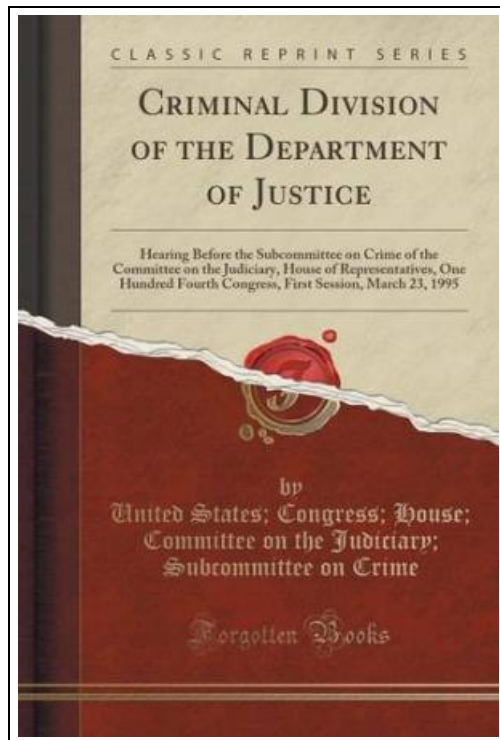

This Division is responsible for both overseeing Federal prosecutions throughout the country and in many cases actually prosecuting violators of Federal law. There are some 15 sections and offices in the Criminal Division. Their combined jurisdiction covers the widest range of issues, including organized crime, terrorism, espionage, child pornography, money laundering, public corruption, violent crime, white-collar crime. All of these issues are important, and, yet, the Division faces constant challenges of identifying and pursuing new law enforcement priorities. Recently, the Justice Department has submitted a plan to Congress for reorganizing the Criminal Division. By the Departments...
